Dr. S.K. De of the University of Dacca in
the list of persons interested in Sanskrit
learning.

The Curator, Oriental Manuscripts Library,
Madras, desires that the name of Dr. S.K. De of the
Dacca University should be included in the list of
persons and institutions interested in Sanskrit
learning. The list is one issued by the Government of
India, that Government should be addressed for the
inclusion of Dr. De's name in the list. In a similar
case disposed of in 1918 it was decided that this
Government's recommendation should be restricted to
persons living in this Presidency and that the in-
clusion in the list of persons resident in other pro-
vinces is a matter for the Government of those Pro-
vinces. This decision may be followed in the present
case. As Dr. De has presented copies of his works to
the Oriental Manuscripts Library, Madras, his name may
be included in the free distribution list of publica-
tions of the Library. A draft order is submitted.
