Mr.W.B.Brierley Principal, Government Brennen  
College, Tellicherry who was granted leave on average pay  
for eight months from or after 16- 1- 25 (G.O.No.R.3 Law  
(Education) dated 6- 1- 25) was permitted to avail  
himself of the leave after handing over charge to the  
Senior Assistant Lecturer of the college. Accordingly  
Mr.W.B.Brierley handed over charge to M.R.Ry S.V.Venkataraya  
Sastri the Senior Assistant Lecturer of the college on  
15- 1- 25 After noon. Mr. S.V.Venkataraya Sastri held  
charge of the Principalship up to 14- 2- 25 After noon  
when Mr. R.M.Savur joined his appointment as officiating  
Principal. The delay in Mr. Savur's taking charge of

the

the Principalship was partly due to the late receipt of instructions from Government regarding his posting.

2. As M.R.Ry S.V.Venkataraya Sastri held charge of the Principalship of the college and discharged the current duties of the post in addition to his own from 16-1-25 to 14-2-25, I have the honour to request that Government will be pleased, under para 2 of the subsidiary rules to Fundamental Rule 49, to permit M.R.Ry S.V. Venkataraya Sastri to draw in addition to his own pay in the Subordinate Educational Service, one-tenth of his pay for the period he discharged the current duties of the Principal.

3. M.R.Ry S.V.Venkataraya Sastri's substantive pay in the Subordinate Educational Service is Rs.205 per mensem. The extra cost which comes to Rs.20-13-0 can be met from the allotment for pay of establishment for Arts colleges-Men in the current years budget.
