The bicycle supplied to the Presidency College, Madras vide G.O.No. 166 R. Educational dated 28-4-1910-is reported to have been condemned by the Superintendent, Public Works Workshops, as un-serviceable and the Principal of the College has therefore applied for its immediate replacement by a new bicycle costing Rs 150/- The cost of the new machine can be met from the provision under "Other Contingencies" of the college in the current year.

The Accountant General, whom I consulted about my sanctioning powers under sub para 3 of item 18 of appendix F to Volume II of the Madras Treasury Manual, in regard to the -- replacement of bicycles originally purchased with the sanction of Government, points out that the renewal in this case requires

also the sanction of Government, as under sub para 7 against item 18 of appendix F, Madras Treasury Manual, Volume II, the Director is authorised to sanction the local purchase of bicycles for his own office or for the offices of the District Educational Officers and Inspectresses and no mention is made of any other office, College or school. I doubt whether the Accountant General's interpretation is correct seeing that sub para 3 of item 18 quoted supra specially refers only to the initial supply of bicycles with the sanction of Government. I have already raised the question of my powers in regard to fresh supply of bicycles to Inspection Offices vide my letter R.O.C.No. 424 A of 24 dated 12th January 1925, and I request that the Government while according sanction for the expenditure referred to in para 1 supra, will give a ruling on the point raised in this letter also.

I request the favour of very early orders as the Principal, Presidency College reports that the college is much -- handicapped in the absence of a bicycle.
