Under article 158 of the Civil Account Code, Volume I, the Government sanction the payment of an advance of Rs. 200/- ( Rupees two hundred only) to M.R.Ry. K.S. Vaidyanatha Ayyar, Deputy Inspector of Schools, Kumbakonam Range, towards the purchase a spring bandy ~~with~~ and a pair of bulls. The advance which should not be drawn until it is actually required will be recovered in eight monthly instalments of Rs. 17 each and four further monthly instalments of Rs.16 each.

2. Interest at five per cent per annum will be charged on the amount of the advance and will be recovered in a single instalment after the principal has been completely repaid.
