The sum of Rs.22,000 referred to above is the provision for grants to Special(training &c) schools for Europeans. There are no Govt.schools for the training of European teachers. In the case of male teachers these are deputed for training in the training school at Ghora Gali in the Punjab. Stipends and travelling allowance are paid from provincial funds to such teachers. In the case of female teachers, there are two training schools in the Presidency namely, the Church Park Training school, Teynampet, and the Training school for Women at Lovedale. Teaching grants are given towards the cost of staff and contingencies of these schools and grants are also given towards the payment of stipends and travelling allowance to ~~women~~ teachers undergoing training in these institutions.

2. The details of the provision of Rs.22,000 are given below:-

(i) Teaching grants

These grants are given with reference to section v of chapter **XI** of the Code of Regulations

for European schools. Of the provision made under this head, Rs.4,500 is for the Church Park Training School and the balance (Rs.500) for the school of Dress-making and needle work, New Town, Madras.

(ii) Stipendiary grants

These grants are given under Art.121 of the Code of Regulations. The details of the provision under this head are as follow:-

(iii) Miscellaneous

The sum of Rs.8,000 provided under this head represents the grant payable to the training school at Lovedale. The details of the provision are shown below:-

The Lovedale Training school was first opened for a period of two years which expired on the 31-12-24. The retention of the school has since been sanctioned for a further period of two years.
