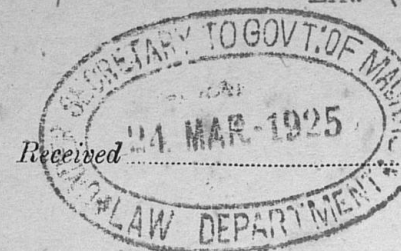

The Inspector of European Schools represents that, if the orders relating to differential rates of fees issued in G.O.No. 197 Law (Education) dated 9-2-25 are given effect to from the date of the order, it will not only dislocate the finances of the schools for the current term but it will also probably necessitate contentions, adjustments of fees paid and agreements arranged, and that he has already had representations from several schools of the difficulties they will be put to by the abrupt application of the order. Accordingly he recommends that the orders may be given effect to only from the beginning of the second term of 1925.
