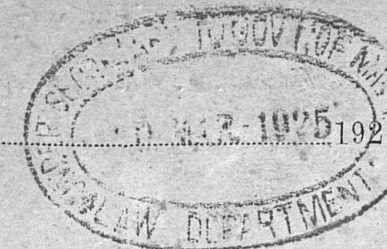

Sir.

I have the honour to state that it is extremely difficult to secure the services of Women graduates in Mathematics and Science so much so that several appointments in the Government Secondary and Training Schools for women are being held at present by men. Further the starting pay of Rs 75/- sanctioned for women graduates is low and the few women graduates in Mathematics and Science that are available are un-willing to take up the post on that pay. This difficulty has already been represented to Government by me vide this office letters R.O. No. 727-G/23 dated 23-11-23 and 21-3-24 and Government were pleased on those occasions to accord permission as a special case to allow Miss M. Pakiam and Mrs. M. Parvati to draw Rs 100/-
