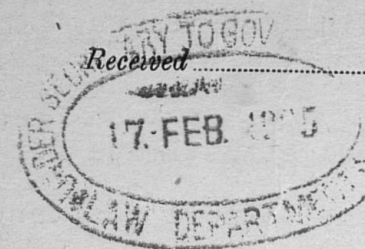

3. The Council has not shown the contribution out of its
general revenues towards the elementary education fund. In
the Budget approved in G.O.No. 863 Mis Law (Education) dated
22nd June 1923, the Council's contribution for 23-24 was
fixed at Rs 3,614. This should be shown in the actuals for
23-24 and a similar contribution entered in the Budget Estimate
for 24-25.

5. A sum of Rs 90/- is shown in the Budget Estimate for 24-25 under "Capitation Allowance". The Council's attention may be invited to sub para (b) of G.O.No. 863 Mis. Law (Education) dated 22nd June 1923.

With reference to the budget approved in G. O. No. 863 ED, dt/ 22nd June 1923, a sum of Rs. 3,614 should be shown as municipal contribution in the R-E. for 1923-24. A similar contribution should be provided in the Budget estimate for 1924-25 also.

With regard to (1) it may be observed that Rs 3614 is the contribution approved by the Council for 1923-24 in the S.S. budget of that year and this sum was actually contributed to the S.S. fund in that year.

There is likewise no objection to accept it. With regard to (2) it may be stated that the contribution provided in the Council's general budget for 1924-25 was only Rs 1603.

Though according to that budget the Res. acch closed with a balance of Rs 5919 representing S.F.C. of the order, income and the R.E. acch with a large balance of Rs 12,842 this dept. did not then find it necessary to raise the contribution for that year which, as already provided, (Rs 1603) was in excess of the contribution paid in 1921-22 (viz Rs 642). 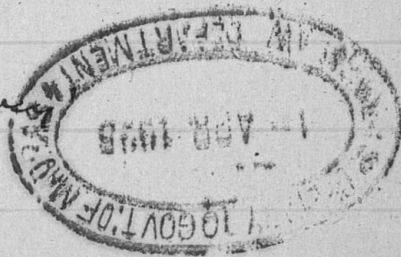
