Copy of letter from the Government of Burma to the Secretary to the Government of Madras, Local Self Government Department No. 985-25 (R.N.76) dated 16-3-25.

Deputation of Mr. M.M. Ohn Chine and Major H.B. Scott, O.B.E., I.M.S., to visit medical institutions in India with a view to determining the needs of the Medical Faculty of the University of Rangoon.

I am directed to say that Major H.B. Scott, O.B.E., I.M.S., F.R.C.S.E., and Mr. M.M. Ohn Chine have been deputed to visit medical colleges and institutions in Madras to collect information regarding the type of building, equipment, organisation etc., of medical institutions with a view to determining the needs of the medical faculty of the University of Rangoon. The Governor in Council will be greatly obliged if, with the permission of His Excellency the Governor and of the Hon'ble Minister in charge Major Scott and Mr. Ohn Chine could be given facilities to study the system of administration and management of the institutions in the province and with the permission of the Governing Body, the organisation of the Medical Faculty of the University. I am also to request that with the permission of His Excellency the Governor and the Hon'ble Ministers in charge Mr. Ohn Chine may be given facilities to visit technical industrial and other educational institutions. A tour programme will follow shortly.
