Sir,

With reference to G.O.No. Mis.483, Law (Edu), dated 2nd April 1924, I have the honour to inform you that the sum of Rs.30,000 placed at the disposal of the University towards the salary of the Vice-Chancellor for 1924-25 has been exhausted and that funds will be required to pay on 1st April 1925 the Salary of the Vice-Chancellor for March 1925. The Senate at its meeting held on 18-3-1925 accepted the draft Statutes relating to the appointment of the Vice-Chancellor, one of which states that the Vice-Chancellor^{shall} be paid a salary of Rs.2000 per mensem, and these statutes have received the assent of His Excellency the Chancellor. The amount required for the purpose for 1925-26 will be Rs.25,323 as detailed below.

Under Sec 11(1) of the Act, the salary may be prescribed by the Statutes.

Salary at Rs.2500 per mensem for the present incumbent from 1-3-25 to 20-5-25	Rs. 6612	as. 14	ps. 5
Salary at Rs. 2000 per mensem for the new incumbent from 21-5-25 to 28-2-1926.	Rs. 18709	as. 10	ps. 10.
	Rs. 25322	as. 9	ps. 3.

I have therefore to request you to be so good as to make very early arrangements to place at the disposal of the University the amount required for 1925-26.
