The Government are pleased to sanction a grant of Rs 1,280/- to the D. E. C., Madras, and of Rs 1,732/- to each of the other District Educational Councils (excepting the District Educational Councils, the Nilgiris, Vizagapatnam and Malabar) to enable them to meet the charges on account of establishment, travelling allowance and office expenses in the year 1925-26. The grants will be subject to final adjustment after the budget estimates of the Councils for 1925-26 are reviewed.

2. Sanction is also accorded ^{to} ~~for~~ the payment of to the District Educational Councils.

Councils, the Melgiris, Vizagapatam and
Malabar of the grants noted in the margin
to enable the Councils to meet the charges
on account of travelling allowances.

3. The Accountant-General is
requested to place the amounts at the
disposal of the District Educational
Councils at an early date. The Presidents
of the Councils will arrange to present
bills at the treasury and either
draw the amounts or get them
adjusted to their credit.

4. The expenditure will be met
from the provision of Rs 50,000 under
