1. Read G.O. No.s.175 and 806 Mis Law(Education) Department dated 5-2-24 and 19-5-24 respectively regarding the ---- formation of Associations of Non-Mission teacher ----- managers of ~~Education~~ Elementary schools in the ---- District.

Read also the remarks of the Director of Public --- Instruction, Madras, on the subject.

Resolution.

This committee recommends to the Council the rules ----- attached for adoption..

RULES

1. Non-Mission Managers Association may be organised one to each range area. It shall be a properly constituted -- body with the usual Office and arrangements for keeping minutes.

The District Educational Officer may accord recognition to such associations on the recommendation of the Deputy Inspector of schools.

2. Each recognised Range association may elect two --- members, and the members so elected of the range in each Taluq Board area may elect from among themselves one --- representative for the council.
3. The election for the ~~council~~ council shall take place at - one of the range.centres to be selected by the District Educational Officer.
4. The results of these election will be communicated by -- the District Educational Officer to the President, Dt. Education Council, who will take the necessary ---

steps to obtain the authorisation required on the section 5(6) of the Elementary Education Act.

5. The election of the council member will take effect ---- from the 1st January 1925.
