Report on the audit of the Elementary Education Fund accounts of the Gudiyattam Municipality, North Arcot district, by Mr. J.M. Hooper, Examiner of Local Fund Accounts, Madras, for the period extending from 1st April 1923 to 31st March 1924.

The audit of the three quarters of the year under report was commenced on 5th February 1924 and ended on the 1st March 1924 and that of the fourth quarter was commenced on 23rd June 1924 and ended on 9th July 1924.

2. During the period under audit the office of Chairman was held by M.R.Ry.K.G.Ramaswami Chetty Garu.

3. The audit was conducted by the District Inspector Mr. M.R. Gopala Ayyar and a note on the defects found in the accounts has been forwarded to the Chairman along with the Municipal audit notes for the same period. The general result is satisfactory.

4. The Council incurred a capital expenditure of Rs.937 which was partly met out of the unspent balance of the Government grant (Rs.604) and partly by the contribution from the General Account budgetted for ordinary expenditure on elementary education (Rs.333/-). The sanction of Government should have been obtained for the utilisation of the unspent grant as it is otherwise refundable to Government being included in the sum of Rs.11,712-5-10 referred to in Government Order No.1022, I&M., dated 2nd May 1923.

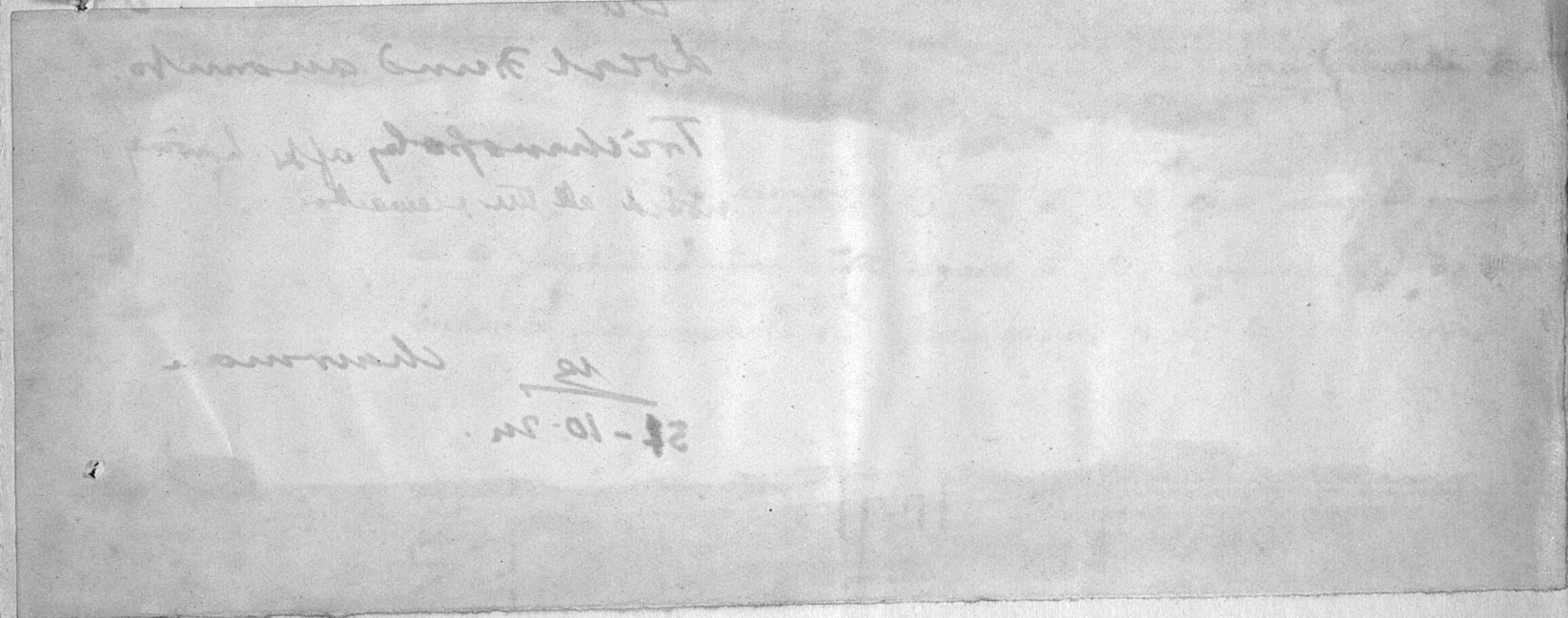

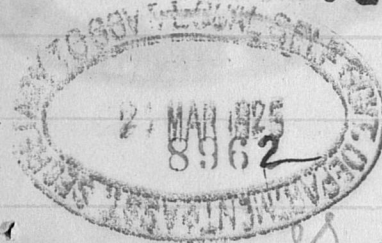
