I have the honour to submit below a scheme for the opening of a manual training class in wood work in the Government Training School for masters, Madras.

2. Instruction is proposed to be given to about 171 students under training and 50 pupils of 11 years of age and over belonging to standards III to V of the practising section.

The training students will be divided into batches of about 40 at a time and the pupils of the practising section will be divided into 3 sections and each section will receive $\frac{1}{2}$ a days instruction per

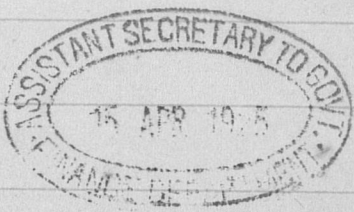
