Sir,

I have the honour to submit below a scheme
for the introduction of a manual training class in
weaving in the Government Training School (Secondary
and Elementary) for Masters, Coimbatore.

2. Instruction is proposed to be given to
about 128 students under training in batches of about
12 at a time each batch receiving half a days
instruction per week.

3. The District Educational Officer reports
that he has secured a building close to the school
building for a rent of Rs.30 per mensem as it is not
possible to erect a shed in the school compound

4. Mr. Porrett who examined the scheme estimates the initial and recurring charges at Rs.1000 and Rs.1080 respectively as per details given in the margin

5. Should the scheme commend itself to Government I request

that sanction may be accorded with effect from the beginning of the next school year and that the necessary provision may also be caused to be inserted in the Budget Estimate for 1924-25 now under the consideration of Government.

6. Sanction may also be accorded to the employment of an Instructor on Rs.50 per mensem in the school.
