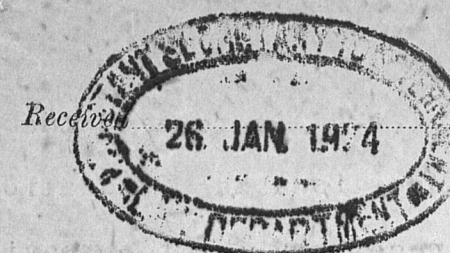

Sir,

I have the honour to submit below a scheme for the introduction of weaving in the Government Training School, Srivilliputhur.

2. Instruction is proposed to be given to about 80 students under training in batches of about 10 at a time each batch receiving 2 consecutive periods of instruction per week.

3. Mr. Porrett who examined the scheme estimates the recurring and non-recurring charges at Rs.810 and Rs.460 respectively as per details noted in the margin

Would the scheme commend itself to Government I request that it may be sanctioned with effect from 1st March 1924 and that the necessary funds may also be provided in the Budget Estimate for 1924-25 which is now under the consideration of Government. Sanction may further be accorded to the employment of an Instructor on Rs.40 per mensem in the school.
