2. The D.P.I.'s demand under this head was Rs. 47,300. This amount is split up ^{in the budget} into two items, Rs. 33,800 ^{being} the equivalent of £ 3,380 at Rs. 10 a pound-being provided for under 31 G - Education-Expenditure in England and the balance appearing under 'Loss in Exchange.'

3 It is not clear why the Hon'ble Member proposes to cut out the provision. Year after ^{year} the equipment in the institutions has to ^{be} renewed and expenditure is inevitable. Presumably the Hon'ble member might suggest the purchase of these articles in India. It may be explained to him that such articles as can be had in India are invariably purchased in the country and that the above provision is only for articles that are ^{not} either available or cannot be purchased with advantage here.
