p 209. 1384. Khan Bahadur P. Khalifulla Sahib:

To reduce the allotment of Rs 10,43,800 for direct ~~XXXXXX~~ grants to non-Government secondary schools by Rs 100.

(To draw the attention of Government to the present practice obtaining in non-Government secondary schools of not giving effect to the G.O. allowing half-free concessions to Muslim students.)

The rule regulating fee concessions in Schools Colleges is as follows:-

"Fees in all institutions shall be levied at half the standard rates from Muhammadans, Oriyas, girls and members of backward classes and castes whose parents or guardians are so poor that the grant of this concession is necessary to enable them to continue their studies. The production of a ~~XXXXXX~~ certificate to that effect signed by an honorary Magistrate, a President of a local board, a district secondary education board or a district educational council a chairman of a ~~XXXXXX~~ council, a sub-Magistrate or an officer of the Revenue department of not lower rank than a deputy tansildar should be required in cases of doubt."

Under rule 32 of the Grant-in-aid code the fee income foregone by the grant of the concessions under the rule extracted above is made good to the management by the Government. Private managers are not therefore put to additional expenditure from their funds by the grant of fee concessions admissible under the rules. The Hon'ble member has probably specific cases to cite where the concessions are not granted.
