Sir,

I have the honour to submit below a scheme for
the introduction of a manual training class in weaving in
the Government Training School, Erode.

2. Instruction is proposed to be given to about
125 students under training in batches of about 10 to 12
at a time, each batch receiving 2 days' instruction per
week.

3. Mr. Porrett who examined the scheme estimates
the recurring and non-recurring charges at Rs. 900 and Rs.
1000 respectively as per details in the margin.

2. Sanction is also accorded to the incurring of a recurring expenditure of Rs 300 a year on contingencies and rent of

will be met from the provision

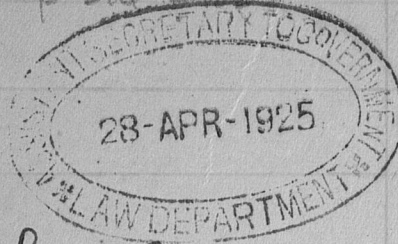
