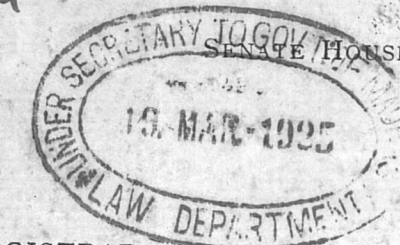

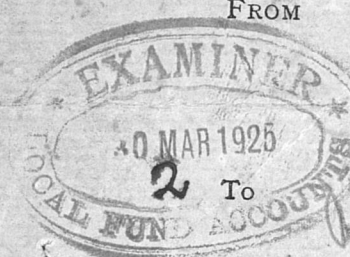

Sir,

With reference to G.O. No.93, Law (Education) dated 21st January 1922, sanctioning the revised estimate of expenditure of Rs 2,61,000 on account of the Tamil Lexicon, I have the honour to state that in the detailed estimate accompanying this office letter to Government No.508 dated 21st January 1921 the approximate cost of printing 1000 copies of the publication was put down as Rs 25,000/-. As it was subsequently decided by the Syndicate that 2,000 copies should be printed and that a better kind of paper should be used, the estimated cost of printing would come to about Rs 40,000/-.

In the course of the audit of the accounts of the Tamil Lexicon, The Examiner of Local Fund Accounts observed that the sanction of Government should be obtained for the deviation from the original estimate of printing and that the source from which the excess is to be met should be pointed out. The remarks of the audit department were considered by the Syndicate at its meeting held on 7th March 1925 and I am directed by that body to inform you that the University Authorities are now printing 2000 copies of the Tamil Lexicon instead of 1000 copies as originally contemplated but that the increased amount of expenditure involved viz., Rs 15,000/- will be met from the sum of Rs 2,61,000 already sanctioned by the Government for the publication and that fresh sanction

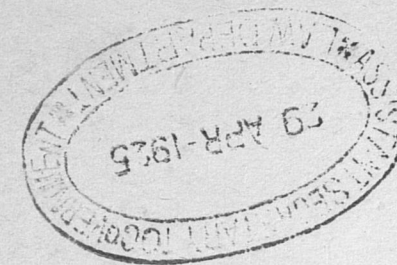
