I have the honour to submit below a scheme for the
introduction of weaving in the Board Higher Elementary
School, Mankarai under the Palghat Taluk Board.

2. Instruction is proposed to be given to about 144
pupils of 11 years of age and over belonging to standards
V to VIII of the school in batches of about 15 pupils
at a time each batch receiving half a day's instruction
per week within school hours.

3. Mr. Porrett who scrutinised the scheme estimates
the recurring and non-recurring charge including the
cost of putting up a temporary shed at Rs 510 and Rs 612
respectively as detailed in the margin.
