In exercise of the powers conferred by section 27 of the Indian Universities Act, 1904 (VIII of 1904), the Governor General in Council is pleased to direct that the following amendment shall be made to the notification of the Government of India in the Home Department, No.717-Edn., dated the 20th August 1904, namely:-

In the first and second columns of the table in the said notification, for the headings "Province (including any Native State under its political control and any foreign possession included within its boundaries)" and "Native State or Colony", the following headings respectively shall be substituted, namely, "Province (including any State in India which on the 20th August 1904 was in political relations with the local Government of the province, and any foreign possession included within its boundaries)" and "State in India or Colony".

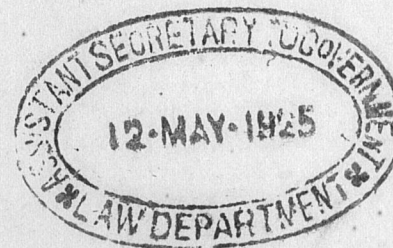
