The proposal to utilise the whole of the provision for grants-in-aid for girls' schools only is hardly feasible. The number of aided elementary schools for boys, which is considerably in excess of that for girls, will go without any grant and will have to be closed. ~~and the whole of the provision for grants-in-aid for girls' schools only is hardly feasible.~~ Besides the number of aided elementary schools for girls is so limited that, even if the rates of teaching grants are increased as proposed, the whole of the provision of Rs 30.73 lakhs will not be needed for the payment of grants to such schools. As regards the proposal to raise the rates of teaching grants in respect of girls' schools by 50 per cent, it is submitted that the rules framed under the Elementary Education Act empower District Educational Councils to raise the rates even by more than 50 per cent in deserving cases. The rules for the payment of teaching grants are sufficiently elastic and there is no reason why the rates should be ~~raised~~ increased in respect of all girls' schools, irrespective of their needs or their efficiency.

The amount paid in 1923-24 was only Rs 4.33 lakhs
