Mr. V. Madhava Rajal :-

1312. To reduce the allotment of Rs. 15,97,600 for
Local Bodies - by Rs. 100.

(To obtain increased grants for expansion of
primary education and to give increased pay to teachers).

The provision for grants to local bodies
for primary education (voted and non-voted) has
increased from Rs 44.09 lakhs in 1923-24 to Rs 53
lakhs in 1925-26. In the current year, 839 elemen-
tary schools were opened through the agency of
taluk boards ^{levying the education tax} and provision has been made in the
next year's budget for the opening of 1017 addi-
tional elementary schools. Thus, every endeavour
is being made to expand elementary education, so
far as the funds at the disposal of the Government
will permit.

2. As regards increased pay to teachers,
it is submitted that this is purely a question for
local bodies. The Government have issued orders
deprecating the utilisation of the proceeds of the
education tax in raising the salaries of the
teachers, as the opening of new schools will there-
by be retarded. In special cases where suffi-
cient grounds have been shown, the Government permit
local bodies to utilise a portion of the proceeds
of the education ^{tax} ~~cess~~ for raising the salaries of
teachers.
