The pay of ~~the~~ secondary grade teachers is

as follows:-

Trained male teachers Rs 35-35-1 $\frac{1}{2}$ -50-1-60

Trained female teachers. 45-3-90 with a selection grade of Rs. 100.

The pay of teachers in schools under local bodies is different in different districts. There is no reason why the pay adopted in Government schools should as a matter of course be followed in schools under local bodies. ~~The teachers in Board and Municipal schools under local bodies. The teachers in Board and Municipal schools~~ are as much subordinates of those bodies as the clerks and other employees working under ~~them~~ them are. The question of the pay to be given to such teachers is a matter primarily for the consideration of the local bodies concerned. Such pay should obviously be fixed with reference to the circumstances of the locality in which the school is ~~situated~~ situated. If any local body finds that the pay offered by it is not sufficient to attract qualified

teachers and if the local body is unable to meet from its own funds the cost of raising the pay of the teachers ^(in its service) the Government will consider the question of giving a subsidy to the local body for the purpose.
