As the Elementary School for Muhammadan Girls at Mangalore continues to be a Government institution and as the revised scale of salaries has not been sanctioned for that school, capitation allowance due for 1923-24 has to be paid to the teachers. As the Government Elementary School for Girls at Nizampatam and Kumbakonam have been transferred to Local bodies with effect from 15-5-24 only (vide G.O.No.780 Mis., Law (Education) dated 13-5-24) capitation allowance has to be paid to the teachers of these schools also for the year 1923-24.
