The present D.E.O. has recently joined (Mr.V.C.Srinivasa Acharya). He informs me that the office of the D.E.O. is located on the first floor of a block of buildings situated in a corner of the compound in which the Government Training School, Tanjore, is. The westernmost room on this first floor has long been used as residential quarters by the D.E.Os on a monthly rent of Rs.14. The D.E.O. states that four different officers were living in these quarters for a period which totals about 6 years. The present D.E.O. has actually stopped in these quarters only three days and does not propose to stay there as soon as he can secure suitable accommodation

accommodation elsewhere. He does not consider that such residence is prejudicial to the discipline of the school as the residential portion is in a ~~xxxx~~ remote corner and is practically shut off from view from the training school. Moreover it has a separate entrance.

If my memory serves me correctly this is the fifth question asked by Mr. Satyamurti recently regarding this school. The following answer is suggested:-

(a) The D.E.Os of Tanjore have been occupying a portion of a block of buildings which are situated in a corner of the school compound with a separate entrance.
