So far as is known, Mr. Bhadrachari is the only officer of the Jain Community in the S.E.S.

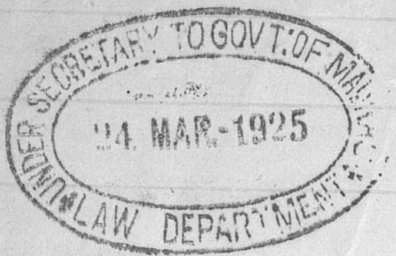
