Karikavali (the standard sanskrit work on logic) is valuable for the three new commentaries named Prabha, Mangesha and Ganga ramaja-teeya which have now for the first time seen the light of print having been prepared with great pains from old and moth eaten palm leaf manuscripts in which form alone they had been available. The book entitled Nilakantavijaya has been published, it is reported, for the first time in Sanskrit

Devanagari Characters. Its author is the famous Nilakanta Dikshita who flourished in the earlier half of the XVII Century. The price of the 1st book is Rs 12 per copy of the second Rs 2/- per copy and the funds required for the purchase of 15 copies of each of the works can be met out of the sum of Rs 9900/- under 31 E-a-Education-General-Direction-Non-contact contingencies-Voted in the current year's budget.
