It is now proposed to have in lieu thereof a Draughtsman on Rs. 25, a Clerk on Rs. 15, and three lascars on Rs. 6 a-month. PROCEEDINGS OF THE BOARD OF REVENUE, dated 17th January 1881.

Read the following letter from H. T. ROSS, Esq., Vice-President of the Local Fund Board, Vellore Circle, to W. S. WHITESIDE, Esq., President of the Local Fund Boards, North Arcot District, dated Vellore, 24th November 1880, No. 552 :—

In forwarding copies of Resolutions 2 and 4 agreed to at the meeting of the Local Fund Board held on the 21st September 1880 and 19th November 1880, respectively, I have the honor to request you will be good enough to obtain the sanction of Government to the entertainment of the following establishment for the Assistant Engineer :—

One lascar on Rs. 6 in addition to the existing two lascars.
One Draughtsman on Rs. 25 ; the present Clerk on Rs. 20, who is qualified as a Draughtsman, to be appointed as such.
One Clerk on Rs. 15.
