Sir,

With reference to G. O. No. 1889 Judicial,
dated 15th September 1893 and in continuation of this Office
letter Ref. on Current No. 4322 dated 14th August 1894, I have
the honor to report that letter of Administration has been
granted to the applicant in question, but that the District
Judge informs me that he has decided not to levy
Stamp duty for it, as in 1884 in respect of the same Estate
letter of administration was given and stamp duty amounting
to Rs 912 Collected under Art. II Schedule I of the Court Fees
Act at 2 p. c. on the value of the Estate which was esti-
- mated to be worth Rs 45600. The present under-valuation
is therefore immaterial, and I may add that the Tahsildar
on the occasion of the 2^d application valued the estate at only
Rs 40169. The District Judge's decision seems to be in accordance
with the provisions of sec. 19 C of the Court Fees Act.
