Kasurkur Tammoovjee
Now, a prisoner who is
Sentenced to 3 1/2 years
by the High Court at
Madras & now confined in
Her Majesty's Penitentiary
at Madras, most respectfully
sheweth.

That the humble petitioner was a Postal Peon
and served for (23) Twenty three years in the Postal
Department without any irregularities. A certain
Money order issued from Parbatipuram Post office
in the address of P. Sooria Narain Son of Brother Black
Town Madras of Supur Ninetien & amount of this
money order was handed over to me by the money order
clerk duly taking my Signature in the Money order
Journal and entered in my delivery Book. There
was another Gentleman in the same name as P.
Sooria Narain, Brother, of Theatre company who came
shortly and was residing at Black Town, whom
I know by sight, and believing him that the above
mentioned money order belongs to him, I paid
the amount duly taking the proper Signature a few
days after, the Real person complained in the
Post office for the above sum, then the Presidency
Postmaster asked me to get the man to whom I paid
the money & deposit the sum of Rs 19/4 to him, but
as the person of Theatre Company being left Madras
I am unable to produce him before the Presiding
Postmaster, but being feared I deposited the above
sum from my own Pocket. The Presidency Postmaster
without due Consideration handed over to the Police

and the Police brought charge against me, that
I myself made forgery of the above money order.
You honor Can easily consider a man who never
did any mischief during his 23 years Service and
he will ~~make~~^{do} forgery of Rs 19/4/- which is quite
misunderstanding of the Presidency Postmaster
I therefore earnestly crave that your honor will
be graciously pleased as to consider the above
circumstances.
