I have the honor to request that the Government will be pleased to sanction a fee of Rs. 75 to the Public Prosecutor, Trinerelly, for his services in Sessions case No. 14 of 1895 (Sections 467 and 471, I.P.C.) on the file of the Sessions Court, Trinerelly. Eight witnesses were examined for the prosecution and three for the defence. The accused was sentenced to 4 years' rigorous imprisonment and 400 Rs fine - in default, one year's further rigorous imprisonment. The trial of the case occupied 4 days.
