1 Abstract Estimate.

I have the honor to forward herewith, for the sanction of Government, an Estimate received from the Garrison Engineer, amounting to Rupees (235) two hundred and thirty-five, for alterations and additions to the Case-mated new Godowns attached to the Commissariat Department in Fort Saint George.

2. The work was commenced on emergency by the Garrison Engineer, under the instructions of His Honor the Governor, communicated through the Town Major.

3. The estimate has been duly examined and found to be moderate, but sufficient.

ORDER, No. 269, 20th January 1860.

Approved. But the Governor in Council observes, that the item in the estimate for fixing the Charloos appears excessive.
