Letter from Sergeant J. Murphy, Overseer,
P. W. D., to the Executive Engineer, No. II,
Periyar Division, No. 1, dated 19th January/91.

In reply to No. 939.S. dated
17-12-90 from the Executive Engineer, on No. 5.P.R.
dated 4th December 1890, from the Superin-
tending Engineer calling for further ex-
planation regarding any claims to
Sub Division allowances. I beg most
respectfully to state that I have received
Sub Division allowances while in charge
of B & C Subdivisions from 28th August/90
only; whereas I claim for the whole period
from 13-2-89 to 19-9-89 or for 7 months
and 7 days.

From the correspondence and
enclosures sent up with my letter No.
dated 5-11-90. I have clearly shewn
that I was for the whole period of 7 months
7 days doing the duty of a Sub Division
officer directly under the orders of the
Executive Engineer with no intermediate
officer between us.

I therefore request that you
will

will be so good as to obtain for me the Sub Division allowance claimed for the full period of 7 months and 7 days. But should my charge for the full period of 7 months and 7 days be not considered as duly authorized Sub Division, I beg it may be specially so treated in order to pass to me the allowances I claim and which were paid to my successors on the same duty. The duties performed by me for the 7 months 7 days were the same as those carried out by Messrs. Ellis, and Kristmanachariar Subsequently. They have received Sub Division allowance, while I, owing to my rank being overseer, have, I think been precluded.

Letter from the Executive Engineer N^o II, Periar Division to the Superintending Engineer Nileakle N^o 266 S.E. of 28th January/91.

With reference to your N^o 5 P.R. of 4th December/90, I have the honor to state that the overseer claimed Sub Divisional allowance for the periods between the 13th February and the 27th August/89. In reality he wants the formation of the Sub Division antedated to the

13th February. He was during that time doing the duties of a Sub Division officer for he had a large number of work people under him over a length of 5 or 6 miles and was doing exactly the same work as the two officers who held the authorized Sub Divisions and drew the allowances.

Under these circumstances I hope his claim may be passed. His letter is enclosed.

Copies of the overseer's and Executive Engineer's letters are submitted to the Chief Engineer D.P.W. for orders.

2. I would appear that the overseer was in charge of B & C Sub Divisions from 13th February to 19th September/89, under the direct orders of the Executive Engineer; whereas he appears to have been allowed Sub Divisional allowance only from 28th August/89; he now claims the allowance for the remaining period from 13th February to 27th August/89.

3. The Sub Divisions do not appear to

have been authorized ones, but Sergeant
Murphy's successors are said to have
been granted the allowance. The claim
of the former therefore appears reasonable
and it is recommended for favourable
consideration.
