In pursuance of a notification which has already been made to you, I have
Extract from Minutes of Consultation No. 275 of 9th May 1857. to request that you will cause the three enclosed blank forms of Returns, numbered 1, 2, and 3, to be filled up with the necessary information, and returned within ten days certified by you as correct.

2. These three returns are merely preliminary, and are intended only to afford particulars as to the strength, the number of changes, the cost, and the subdivisions into departments in the several Offices. It is not intended that they shall include any details of the duties performed by each Officer; all such particulars will be provided for in future returns, in which, such remarks as you consider necessary, may be made.

3. In the Extracts from Minutes of Consultation, which have been furnished to you, the objects of the Commission are fully set forth; it will be seen that Government seeks to introduce a system by which the efficiency of the several Establishments may be tested, such a system of test as will, while it ensures to Government the most efficient and effective organization, secure to deserving Officers of the State, the greatest amount of encouragement.
