Mr. Wood was in charge of the revenue work of the Head Quarter Division until 24<sup>th</sup> February, when Mr. Dutt was transferred as Head Assistant Collector, and Mr. Wood took up the magisterial work also. For a short time Mr. Stokes had revenue charge but from the 17<sup>th</sup> March when the latter was transferred as Head Assistant Collector, Tanjore, Mr. Wood has held both revenue and magisterial charge.

2. He also did the jamabandi of Erode and Coimbatore Taluks. These are heavy taluks and he was given the assistance of a Rs 25 clerk from my office.
