Read the following:-

(1) Proceedings of the Board of Revenue (Revenue Settlement - men & H.) dated 31st December 1897, No. N^o 10292, and Reference N^o 1A, dated 25th January 1898.

(2) Endorsement of the Secretary to the Commissioners of Revenue Settlement, dated 5th March 1898, transferring letter from W. B. Syling Esq., Ag. Collector of Tanjore, dated 3rd March 1898, reporting that the endowment in favour of the Koviladi Chuttram and Travellers' bungalow is being properly administered; and Reference N^o 10, dated 16th March 1898.

(3) The following letter from J. Swigg Esq., Acting Collector of Tanjore, to the Secretary to the Commissioners of Land Revenue, dated 8th July 1898, N^o 3001.

In reply to the Board's Reference on General Register N^o 939 of 1898, dated 16th March last, I have the honor to state that the accounts of the Koviladi Chuttram and Travellers' bungalow for Faslis 1303 to 1305 were examined by the Deputy Collector, Tanjore Division. It is seen from his report dated 21st June 1898 that the accounts

accounts have been regularly maintained, that the charity is properly administered, and that a sum of about Rs. 4,500 is spent annually for the upkeep of the Institution.

Reference N^o 806, dated 20th July 1898, Confidential N^o 21.

The papers read above will be submitted to Government with reference to para 2 of G.O. N^o 5883 Mis., dated 16th November 1897.

2. The Collector reports that the endowment in favour of the Koviladi Chattram and Travellers bungalow is properly administered. The accounts of the trust for faslis 1303 to 1305 have been examined and found to have been regularly maintained and it is stated that a sum of about Rs. 4,500 is spent annually for the upkeep of the institution.

3. With reference to the instructions issued in para 2 of G.O. N^o 82, dated 11th January 1895, the collector will be requested to arrange for a periodical inspection of the accounts in future.
