Thiruvukha Agraharam Village of Paim in the Taluk of Perundurai of Coimbatore District
This Village was originally granted by Not known

On the assumption of this District by the British Government according to the order of the Government dated 2^d July 1801 this Agraharam was resumed and, in lieu the cultivated lands which were paying equal value to $\frac{1}{4}$ of the then full rent of the village were separately granted to the Agraharamdars as a reward of all town & Patta to this effect is also granted to them which contain the names of the different Shares and their respective shares.

Some of the Agraharamdars have subsequently sold made gift and mortgaged their Shares to others
On the present Settlement the Shares held by the descendants of the original holders and that of purchasers, donors, and the mortgagee also, had it previous to 1841 and to which no claim is now preferred either by the Original holders and of their descendants are confirmed to them.

The land is not divided among the Share holders of this Agraharam but the enclosure of the land of each share is formed into shares.

The documents and accounts connected to this Agraharam are entered in Calce of the Register
