The land consisting of pagaman No. 98 (S.F.No.42) was granted for the support of the pagoda of Hare temple in T.D.No. 75. The grant in this case included the land also. The perpetual lease and whether the temple was the heirs of the Insardars who render service in the temple were benefitted from the Insardars land. Hence the Sub Collector, Pollachi in his proceed No. 7761/35 dated 12-12-1935 resumed the Insardars land entered in column 3 with the extent and assessment noted in col. 5 and the Insardars consisting of Velamrao and Kudiyarao was regranted as undergrants to the temple for its support.
