466 was issued. Subsequently
in the year 1910. Kankabesami
Rao, the descendant
of the original grantee
sold the inam lands
to Vammal and Ellammal
of Bannamal patta because
who have been performing
the service. It was therefore
ordered in Government Order
No. 3462 Rev dated 16-11-12
that the original T. D. No. 466
relating to the grant should be
cancelled and a fresh T. D.
issued in the name of the
present occupants of the inam
on condition that they perform
the Vidayathu Kattalai
on the 3rd to 5th festival
days in the Nachiyar Temple
at Srinellipathur.
